

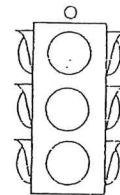
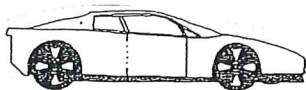

A student driver education 30-hour classroom program for Fairmont area students will begin in October for students 14 years and older. **The class will be held on the following dates: October 28-November 1 and November 4-8. Make up day: November 11. (NO WEEKENDS). Class held in lower level of Human Service Building-use south entrance elevator. The class will be from 6:00-9:00 p.m. to accommodate the schedule of those students in athletics or fine arts. There will be a parent meeting on Monday, October 28 from 5:00-6:30 p.m. Students need not attend but are encouraged too. ALL STUDENTS ARE EXPECTED TO BE AT CLASS FROM 6:00-9:00 P.M. ON OCTOBER 28.** A state law that went into effect a few years ago requiring a parent meeting to be held, which Mr. Uttech and I have done on our own for years. A minimum of 15 students is needed to provide a class. **If there are not enough registrations, parents will be contacted about cancellation of the class after the October 23 deadline. If you do not hear from me, the class is a go!** Students should bring a pen or pencil, highlighter, notebook paper, and folder to class.

## SUMMARY OF THE DRIVER EDUCATION PROGRAM

- \*Students that are age 15 and have successfully completed the classroom program are able to take their state written exam at the examining station.
- \*Behind-the-wheel training (6 hours of driving time) is done throughout the school year. The instructor will contact the student to schedule a time. Instruction is typically taught weekdays between the hours of 3:30-5:30 p.m. during the school year and 8:00-5:00 during the summer.
- \*The instructor will make arrangements with the student/parent for behind-the-wheel instruction.
- \*The student is driving alone with the instructor for one-on-one driving instruction.
- \*By law, students must wait six months after receiving their permit to qualify for a driver's license even if the student is sixteen years old. If behind the wheel openings are available, students that turn sixteen or are sixteen or older within that six-month waiting period, will be completed first as well as those that qualify for a farm permit. Students should let Mr. Uttech know during one of the class days that he/she qualifies for their license early.
- \*Total cost of the driver education program for the classroom phase and behind-the-wheel training is **\$300.00**; the lowest price in town plus we have not had a price increase for years! **Payment Plan Available Upon Request.** Students must have \$200.00 paid by the end of the classroom phase on November 9.
- \*Parents and students should be aware that the hours of classroom and behind-the-wheel-training are the minimum requirements set by law. If a student lacks any of the required time, he/she must make up the time and will be assessed an additional fee of \$30.00.
- \*If a student is unable to complete the classroom and/or behind the wheel program a refund will be available. If the student had already started the class and/or behind the wheel instruction and decides to leave, the money refunded will be prorated accordingly. If a student wishes to take the classroom program only, the cost is \$125.00 and the cost for behind the wheel only is \$30.00/hour.
- \*This agreement constitutes a contract between GHEC/RM Driving and the student/parent and no verbal statements or promises will be recognized. **Thank you in advance for choosing our program!**
- \***Before taking the state written exam, your student must have an original certified birth certificate and social security card.** If your child was born in another state and plans to take his/her written driving exam immediately after completing the classroom program, you should contact the county courthouse as soon as possible in the state/country the child was born to obtain a certified birth certificate.
